## **MCLOUD WATERSHED COUNCIL & CALIFORNIA TROUT ENLIST MANATT**

*National Law Firm Joins Efforts to Protect Communities Rights against  
Nestle Waters North America*

**McCloud, CA** – April 23, 2008 – The McCloud Watershed Council and California Trout, who, along with Trout Unlimited, comprise the Protect Our Waters Coalition, announced today that they have engaged the national law and consulting firm of Manatt, Phelps & Phillips, LLP. The firm will represent the Coalition in their fight to safeguard the rights and quality of life for residents of McCloud, California and beyond who would be affected by operation of a planned Nestle Waters North America water bottling plant in the Mt. Shasta area. Progress on the proposed plant, which would be the nation’s largest, is mired in unanswered questions and conflicting economic and environmental assessments.
